





I am to state that the Hon'ble Vice-Chancellor is pleased to appoint you as Joint Chief Superintendent to supervise the day-to-day arrangement of the conduct of Examinations at **M.S.P.M's Arts, Sci. and Com. College, Lohara, Dist-Osmanabad** Examination Centre. The Examinations at this Centre are commencing from **15.10.2018**, Thus you have to join from **14.10.2018** before the preparation for and commencement of Examination. Therefore you should be remain present at the Examination Centre within scheduled time of downloading of question papers and be present at the time of Packing of Answer Books.

A copy of the "Duties of the Joint Chief Superintendent" has already been sent to the Chief Superintendent/Principal of the Examination Center.

The provision under Section 48(4) of the Maharashtra Public Universities Act, 2016 is reproduced as under :

"It shall be obligatory on every teacher and on the non-teaching employee of the University, affiliated, conducted colleges, community colleges or recognized institutions to render necessary assistance and service in respect of examinations of the university and evaluation of students as prescribed by statutes. If any teacher or non-teaching employee fails to comply with the order of the university or college or institution, in this respect, it shall be treated as misconduct and the employee shall be liable for disciplinary action. In case of failure on the part of the teacher or non-teaching employee of any affiliated college, conducted college, community college or recognized institution, to comply with the order of the university in this respect, the Vice-Chancellor shall have power to take an appropriate action against them, which may include imposing penalties including suspension of approval to the appointment of a teacher, as may be prescribed by the Statutes."

Remuneration form, TA/DA bill, forms No.41 and specimen pro-forma regarding the number of answer books is made available at the center and the university website as well.

Your bills should reach this office along with prescribed papers within a week after reliving the said Examinations centre.
