# **1. EXECUTIVE SUMMARY**

# **1.1 INTRODUCTION**

Shrikrishna Mahavidyalaya Gunjoti run by Shrikrishna Education Society is an esteemed institution established in the year 1991 under the able leadership of **Dr.D.B. Patange** and the then MP **Late Tulsiramji Patil**, The college has been affiliated with Dr.Babasaheb Ambedkar Marathwada University and recognized by UGC under 2(f) 12(B) act of UGC since June 2004. College was accredited a B grade with CGPA 2.26 (Cycle-2) by NAAC in the year 2015. The institution strives to provide excellence in education with the motto "**Education for Deprived**".

Students are motivated to pursue a higher level of academic excellence in the subjects of their choice. These are in tune with the vision and mission of the college which is communicated to stakeholders through prospectus, banners, social media, and website. The college offers 06 UG, 3 PG, UG, and PG programs(one each) by Distance mode, and 05 Ph.D. programs. The curriculum is framed by affiliating university. Feedback received from stakeholders is communicated to University through BOS members. The curriculum is supported by certificate courses/add-on courses/skill-based courses. About 69% of the faculties are Ph.D. holders, 16 are research supervisors recognized by affiliating University, and more than 59 students are pursuing doctoral research. Assessments and assignments are used to evaluate the Student's learning outcome.ABC registration drives are carried out by appointing the nodal person, through mentor-mentee groups and on-call basis to the left-out students. Due care was taken to see that all first-semester students were registered for ABC before the commencement of the examination.

# **2.3 Teaching- Learning Process**

**2.3.1** Student centric methods, such as experiential learning, participative learning and problem solving methodologies are used for enhancing learning experiences using ICT tools

### **Response:**

The faculty employs theoretical lecture method, practical's, field work, project work, class-room seminars, and computer-assisted learning (CAL) wherever and whenever necessary for teaching-learning and evaluation of the students. Generally, theoretical lecture method is most commonly practiced method useful for large groups. The faculties explain points by giving introduction and salient features of the topic. This method is predominantly practiced for B A and B Sc. courses. Experimental assignments were given to the students of computer at UG and PG level. The College, to ensure a good experimental learning for its students, has taken efforts to establish and upgrade its laboratories with advanced equipment. For participative learning, the interactive method i.e. questions and answers between the teachers and the taught is used to clear their doubts. The computer assisted learning is useful for the students with computer as one of the main subject and other faculties especially science faculties make use of power-point presentations and provide online resource materials. This helps both the faculties and students to interact with each other in a different way. The faculties, according to the need of curriculum, engage in using the modern teaching aids. The Geography department make use of charts, maps, telescope to make their teaching effective. Subsequently, the aim of imparting education is not only to help students to gain a good percentage and proper employment but also to make them better human beings and good responsible citizens of tomorrow. To ensure all this, the possible student centric methods of teaching are used in the classroom for supplementing the teaching. Traditional teaching methods are so useful to the common students where the aim is to pass out the program offered by the Institution. Apart from these teaching methods, the students who are hungry to grasp the knowledge, these methods are not enough to them. Using nnovative teaching aids, the teachers motivate the students; accelerate his knowledge and helps in upgrading his subject. Use of teaching aids and tools like computers, audio-visual multimedia etc. would make awareness amongst students about their own subjects. Subsequently, the student centric teaching, a

teacher with full of knowledge and a teacher with innovative teaching by using different tools nurture the creativity hidden in the students. As our university adopted the semester pattern for evaluation of the students, each semester is assigned with a paper for each subject. Under such hectic situation use of ICT material helps the teacher to complete their syllabus within time. In our college teachers especially from science stream effectively using the ICT tools in their daily teaching hours. ICT tools such as Powerpoints, youtube videos are enhancing the conventional teaching method. Teachers are also providing online resources to the students as extra study materials. Students are definitely benefiting by the use of ICT material used by teachers. During the pandemic period online lectures were conducted by using various online platform such as Google meet, Zoom, DigitalEdu etc. College has signed the MOU with DigitalEdu online platform for the teaching staffs to deliver online lectures.

## **Response:**

In the beginning of the academic year the schedule of the internal examination is displayed in the academic calendar, which is displayed on college website. As per the academic calendar, teacher conducts unit tests, and collect Tutorials from the students. After evaluation of test and tutorials; the results are submitted to examination committee for analysis. The examination committee submits the report to IQAC. The weight-age of 20 marks is given for internal assessment. The project work for B. A. /B.Sc Third Year students and PG students is mandatory as per University rules. The science department evaluates the students through practical examinations. The results of unit tests/projects are shown in the classrooms and student can ask about its performance. If there is any discrepancy in their marks, it can immediately be corrected. The concerned subject teacher keeps the record of all internal exams, and practicals etc. and the record is submitted to University alognwith marklists.

The college has constituted the examination committee headed by the the Principal and two-three teachers and one non-teaching staff as its members. The student can raise the grievances after declaration of result of internal examination and University examination.Students can approach to the concern teacherof the subjects. After verification of the grievance the concern teachers forward this issues to the Principal of the college. The Principal directs the Examination committee forward the grievances of the students approach to the compliance in case of University examinations.Re-dressal statement of marks /correction of results is conveyed to the students. At the college level, the student should apply within a three days after declaration of the result. The corrected results are submitted to the university in time bound.

It is executed as per the requirements to meet the national or regional problems or issues. The stated policies are reviewed periodically by the management and stakeholders. The quality policy of the college is committed to pursuing high standards of excellence in all the fields such as

teaching-learning, research, extension, administration, management, sports, cultural activities, etc., with a student-centric approach. The college promotes social and human values through awareness campaigns run by the NSS unit through various activities. For better governance, the Principal, Head of the departments, and Chairman of various committees and IQAC monitors participation and effective deployment of any program undertaken by the student or faculty.? College-Development Committee (CDC) formulated as per Maharashtra-Public University-Act 2016, involves Chairperson and Secretary of Management, Vice- president member, Two members of SES including a member from social working sector, three teacher representatives including IQAC co-ordinator, one nonteaching staff and Principal as member secretary. The Principal presents IQAC minutes in CDC meetings for information/approval. The IQAC, chaired by the Principal, has the responsibility of reviewing the academic outcomes and to plan for the introduction of new programs/courses as per requirements and feedback from various stakeholders. The Principal monitors the administrative staff and distributes the work among the administrative staff for smooth functioning and time-bound completion of the work. ### 6.4 Financial Management and Resource Mobilization

6.4.1 Institution has strategies for mobilization and optimal utilization of resources and funds from various sources (government/ nongovernment organizations) and it conducts financial audits regularly (internal and external)

### **Response:**

The College has a well-functioning mechanism for the mobilization of funds and optimum utilization of resources. For the allocation of funds, the requirements of the departments and

other constituents of the college are evaluated to make the budgetary provision for academic and administrative activities at the beginning of the academic/financial year. The college conducts Internal and External audits regularly. It has an appropriate mechanism to ensure that financial records and statements are shown in a true and fair manner as required by

the Accounting standards and prevailing laws.

? The college is government aided, privately managed and it receives financial assistance from the Maharashtra Government, UGC, Dr. BAM University, Aurangabad and the Governing Council of the college.

? The college gets students fees, grants and scholarships from various agencies and funding organizations besides State Government and non-government agencies

? The accountant of the college maintains all the financial records in accounting using Mastersoft cloud where all cashless transactions take place maintains transparency.

? All the vouchers and bills are duly audited by a team of qualified and well experienced Chartered Accountants. They also conduct audits of the grants received from state government and other funding agencies for organizing academics and research activities.

? To keep the record transparent and to ensure accountability, the college office prepares the balance sheet clearly indicating the amount spent under different heads during those particular periods. The balance sheet is prepared by the Head-Clerk, verified by the Office Superintendent and the Principal and audited by the Chartered Accountant.

? As per the norms of Government of Maharashtra, Higher Education Department, the college conducts its financial audit annually by Accounts Officer (AO), followed by audit by Senior Auditor, Joint Director Office Higher Education, Aurangabad and final audit is conducted by Accountant General, Nagpur, for salary and non-salary grants received from the government.

? There are no major irregularities in audits. The reports of last 5 years audits are ready. Audit objections are promptly resolved. Suggestions made by the auditors for budget allotments are incorporated in the subsequent budget statements.

? Financial assistance for scholarships received from government and non-government organizations are audited by the concerned authorities such as UGC. The statements of expenditure and utilization certificates are audited by an external auditor. The settlement of the accounts is done by the concerned funding agencies. If the funds are not utilized as per the guidelines of the funding agencies, the funds have to be repaid with interest. Optimal utilization of available financial and non-financial resources is done at the campus through meticulous planning.

? Books and other reading material sought through research grants are kept in central library for readers.

? Instruments purchased through grants are used in the departmental laboratories for further academic purposes.

? The central auditorium of the college is used for various curricular, co-curricular, and extra-curricular and for the organization of seminars, conferences, and other academic discourse.
